

# Dock Line Republican Primary Scorecard

Truth • Transparency • Accountability | Generated February 17, 2026

As part of our ongoing commitment to investigative clarity and civic responsibility, Dock Line evaluated Republican primary candidates using a consistent standard built on three core principles: Truth, Transparency, and Accountability. Each candidate below is marked according to documented public record, verified reporting, and campaign conduct.

## What the Check Marks Mean

- ✓ Truth — Public statements align with documented record. No verified pattern of materially misleading claims or unresolved credibility issues in mainstream reporting.
- ✓ Transparency — Willingness to answer questions publicly, maintain a visible platform, engage in Q&A coverage, and address controversy directly when it arises.
- ✓ Accountability — When faced with scrutiny, investigation, controversy, or error, the candidate engaged the process openly and did not evade legal, ethical, or institutional review. Resolution matters.
- ✓✓✓ — Candidate met all three standards based on currently available public record.

## Montgomery County

### County Judge

#### Mark Keough

✓✓✓ **Truth • Transparency • Accountability**

Keough is currently involved in active litigation that includes serious allegations and counter-allegations. Rather than avoiding scrutiny, he has addressed the matter directly through formal legal filings and public statements, allowing the process to unfold transparently. Regarding his prior DWI, Keough pleaded guilty, accepted responsibility, and did not attempt to deflect blame. He has publicly acknowledged the incident and discussed the circumstances, including the involvement of prescribed Ambien, while accepting the legal consequences.

#### Wayne Mack

✓ **Transparency**

Mack has maintained a visible campaign presence and engages publicly, which supports a Transparency mark. However, elements of the current campaign have included aggressive personal attacks and messaging that critics argue mischaracterizes opponents. Additionally, after referencing personal matters in campaign communication, subsequent clarification regarding his divorce history has been viewed by some voters as incomplete or inconsistent.

### County Commissioner - Precinct 2

## **Charlie Riley**

### **✓ Transparency**

Riley maintains a visible public presence and participates in campaign activity, which supports a Transparency mark even with his inability to answer questions completely. Several public statements have been criticized as incomplete or selectively framed. Multiple constituents have reported being blocked or having comments removed from campaign social media pages after expressing disagreement. Critics argue broader political accountability for policy shortcomings has not been clearly demonstrated.

## **Bob Harvey**

Harvey has conducted a campaign focused on policy substance rather than personal attacks, maintaining a consistent and disciplined message centered on fiscal oversight, infrastructure planning, and open government. His rhetoric has emphasized responsibility and ownership, including a willingness to address difficult questions directly rather than deflecting criticism. No verified ethics concerns or adverse legal findings surfaced in this review.

Baker has maintained a visible leadership presence within the county party and has aligned public messaging with documented party operations and organizational priorities. No verified ethics violations or disciplinary findings surfaced in this review.

Winthrow has presented a reform-focused campaign centered on internal party direction and grassroots engagement. No verified ethics violations surfaced in this review. Ongoing disputes regarding internal party narratives and contested characterizations prevent awarding a full Truth mark at this time.

Under Dock Line's Truth • Transparency • Accountability standard, the use of rhetoric characterized as half-truth or attack-driven messaging prevents awarding a Truth mark at this time. No verified ethics sanctions or criminal findings surfaced in this review; however, campaign conduct concerns prevent additional marks beyond Transparency.
